Prof. Raymond Akongburo ATUGUBA is an accomplished lawyer with a strong grasp on issues of policy, law, governance and development. Prof. Atuguba has over 20 years of experience in the fields of constitutional governance and the consolidation of democratic gains; law and policy advocacy; public policy reform (healthcare reform, natural resource governance, justice sector reform, police (security sector) reform); legislative drafting; human rights-based approaches to development; and community organising and mobilisation. Significantly, he has in the course of over two decades, worked at both the lowest and the highest levels in the non-profit, government (public), and for-profit sectors.

For over two years, from 2013 to 2015, he was the Executive Secretary to the President of the Republic of Ghana, working closely with top government officials to process policy options for the attention and action of the Executive President. During this time, and for the very first time, he established a comprehensive, innovative, functionally ICT engineered configuration of the President's Secretariat into relevant focused administrative units to enhance efficiency and effectiveness in service delivery, with an eye to the priority setting agenda of any incumbent President.

From January 2010 and for over two years, he served as the Executive Secretary and Principal Researcher to the Constitution Review Commission (CRC), a Presidential Commission set up by a different President to review the operation of the 1992 Constitution of the Republic of Ghana using broad-based participatory research and mobilisation techniques and ICTs.

Between 2008 and 2010, Prof. Atuguba was a member of the United Nations High Level Task Force on the Implementation of the Right to Development.

Prof. Atuguba is currently Associate Professor at the School of Law, University of Ghana, where he has taught since 2002. He has been a James Souverine Gallo Memorial Fellow at Harvard University; Jennifer Oppenheimer Fellow at Harvard University; Graduate Fellow at Harvard Law School; Sheila Biddle Ford Foundation Fellow at the W.E.B. Du Bois Institute for African and African American Research at Harvard University and a Visiting Scholar at the University of Nottingham in the United Kingdom. Additionally, he has been a visiting Professor at Ku Leuven University in Belgium, the Sciences Po University in Paris, France, and at Monash University in Melbourne, Australia where he taught Human Rights, Law and Development and African Law courses.

As Co-Founder and former Executive Director of the non-profit, Legal Resources Centre, and as Founder and Team Leader of the Law and Development Associates Group of Companies, he has championed the development and application of innovative and creative ideas, solutions, and facilitation techniques for the resolution of some of the most intractable problems of African Polities: from policy, legal, and institutional reform; through equitable access to natural resources, social services, and real justice; to pedagogical development, training, community mobilisation and organising.

Prof. Atuguba is also an astute constitutional law expert, and has argued many times before the Supreme Court of Ghana and Court of Appeal of Ghana leading to ground breaking and precedent setting judgments.
